## **Eligibility**

### **A. Minimum Education :-**

- i) **Airport Ground Staff & Cargo Executive** - Candidates must have passed the Intermediate (12<sup>th</sup> pass) Examination or equivalent from a recognised Board.
- ii) **Airport Loader** - Candidates must have passed the Matriculation (10<sup>th</sup>) Examination or equivalent from a recognised Board.

B. Airport Ground Staff & Cargo Executive – Both Males & Females can apply. Freshers can also apply.

C. Airport Loader – Only Male candidates are eligible.

D. Aviation/Airline certificate or diploma is not required.

E. 10<sup>th</sup>+ITI/Diploma students are eligible for the Airport Ground Staff & Cargo Executive position and can apply.

### **Age**

- i. Applicants for Airport Ground Staff (Customer Service Agent) and Cargo Executive positions must be at least 18 years old as of 1st April 2026, and should not exceed 30 years of age.
- ii. For the Loader position, applicants must be at least 20 years old as of 1st April 2026, and should not exceed 40 years of age.

F. There is no age relaxation for any category.

G. The application shall be cancelled if the candidate fails to mention the date of birth in the application form, is found to be overage or underage, does not possess the mandatory educational qualifications, or furnishes incorrect or false information.

**Character:** The candidate must a character certificate showing that there is no criminal record against the candidate in the past as well as in present.

**Physical Fitness:** No person shall be selected unless he/she is in good mental and physical health and free from any physical defect likely to interfere with the efficient performance of his/her official duties. Hence, candidates with benchmark disability (PwBD) are not eligible.

## **Nature of Work - Airport Ground Staff**

At the Airport, mainly Passenger Check-in, Airline ticket reservation, Boarding, and all Terminal Functions. Passenger and airline satisfaction are key requirements. The work pattern will be three shifts, including the night shift, irrespective of gender and one weekly off on a rotation basis. Career growth is based on performance.

## **Nature of Work – Cargo Executive**

An Airport Cargo Executive is responsible for handling and managing the movement of goods at the airport. Their duties include checking cargo documents, coordinating with airlines and ground staff, and ensuring safe loading and unloading of shipments. They also monitor cargo storage, maintain records, and ensure compliance with safety and security regulations. Additionally, they assist in the timely dispatch and delivery of cargo to avoid delays.

## **Nature of Work - Airport Loaders**

At the Airport, mainly Baggage/Cargo Loading and offloading from the aircraft & trolleys, cabin cleaning functions like cleaning the aircraft, assisting Technicians in the workshop, wheelchair assistance, etc. The work pattern will be in Three Shifts, including the night shift and weekly off on a rotation basis. Career growth is based on performance.

## **Difficulty level of question paper:**

- I. The difficulty level of questions related to academic subjects for Airport Ground Staff & Cargo Executive will be of Senior Secondary (12<sup>th</sup>) level.
- II. The difficulty level of questions related to academic subjects for Airport Loader will be of Secondary (10<sup>th</sup>) level.
- III. The written examination syllabus will be the same for all the positions; however, the English language section will not be included in the examination for the Loader profile.
- IV. **Medium of examination:** The paper will be bilingual, i.e., Hindi and English. In case of any ambiguity between Hindi and English versions, due to a transaction. The English version would be treated as final. No Normalisation.
- V. Minimum qualifying marks for the examination is 40%.

## **Details of Syllabus:**

- I. **General Awareness:-** Current Events of National and International Importance, Games and Sports, Art and Culture of India, Indian Literature, Monuments and Places of India, General Science and Life Science (up to 10<sup>th</sup> std.), History of India and Freedom Struggle, Physical, Social and Economic Geography of India and World, Indian Polity and Governance- constitution and political system, General Scientific and Technological Developments including Space and Nuclear Program of India, UN and Other important World Organizations, Environmental Issues Concerning India and World at Large, Basics of Computers and Computer Applications, Common Abbreviations. Important Government and Public Sector Organisations of India, etc.
- II. **Aptitude & Reasoning:-** The questions in this part intend to measure the candidate's general learning ability. The questions will be broadly based on the Alpha-Numeric Series, Coding and Decoding, Analogy, Following Directions, Similarities and Differences, Jumbling, Problem Solving and Analysis, Non-verbal Reasoning based on diagrams, Age Calculations, Calendar, and Clock, Number System Percentage, Ratio and Proportion, Partnership, Profit & Loss, Average, Time and Work, Time and Distance, etc.
- III. **General English:-** Candidate's understanding of the basics of the English Language, its vocabulary, grammar, sentence structure, synonyms, antonyms, and their correct usage, etc. A simple paragraph and a question based on the paragraph to be asked may be given to test comprehension.
- IV. **Aviation Knowledge:** Indian Aviation, Airport Names, Airport Terminologies, Civil Aviation, Airport Codes, and Knowledge of International Airports.

## **Examination Details**

- I. The written examination contains 100 objective-type multiple-choice questions. Each question carries 1 mark. No marks would be awarded for un-attempted questions.
- II. The examination will be conducted in bilingual (English & Hindi).
- III. There will be no negative marking.
- IV. While filling out the online application form, the applicant should carefully decide about his/her choice of examination centre.
- V. The examination centre once opted WILL NOT be changed under any circumstances. Hence, the candidates should select the Centre carefully and indicate it correctly in their application.
- VI. NIAS reserves the right to cancel any Centre and ask the candidates of that Centre to appear from another Centre. The company also reserves the right to divert candidates from one Centre to another Centre to take the examination.

The date & timing for the interview will be mentioned in the call letter, which will be uploaded on the website.
- III. The interview will be conducted in Hindi and English only.
- IV. There will be no Interview for Loader (Only exam).
- V. Based on the combined performance of the written test and personal round of interviews, a candidate would be shortlisted for final selection, subject to successful completion of their character antecedent verification, followed by a medical test.
- VI. The exam weighs 70%, and the interview weighs 30% only.

## **General Condition**
